Minutes from April 10th, 2023- Approved as presented; [Davis/Codispoti; unanimous]

Financials-

- The net income is \$41,000
- Trail, Festival, and Event income are attached
- Financials were approved as presented; [Zdobinski/Davis; unanimous]

Old Business

- The \$1,200 OGIC Mini-Trail Grant was rejected because there weren't letters of support from the participating wineries
- Christy Eckstein has new titles with the OGIC, she recently applied for a job at Ohio State
- There have been some Issues with Wine Ambassadors regarding wine knowledge or some in appropriate posts they don't know anything about wine, don't post enough, or make inappropriate winery posts
- Workforce Development Auburn Pilot money did not go through
- o Auburn Career Center received money through a different grant so the program will happen
- An Industry Survey will go out to the wineries after vintage, please fill out and return it
- Joe Juniper and Mark Zdobinski agree that a Winery Co-op would be a great service to offer
- The Vintage Ohio Lawsuit settled at \$2,800
- There is \$1,800 in the Scholarship fund with plans to raise funds at the upcoming festivals
- Renewing \$500 to current scholarship recipients who are still in the program and maintain a 2.5
 GPA
- There are currently has 10 mini-trails around the state spread throughout the year
- New trail booklets are going well and getting nice compliments. We are working on getting the Vines & Wines and Canal Country books completed.
- Currently we have 8 New Future Wineries that have received videos to help them through their winery journey
- Isle St. George is continuing to be an issue yet unresolved
- Legislative Mailing included 18 wineries for June Ohio Wine month to the Ohio and Federal elected
 officials
- OWPA is the last to send theirs out on Wednesday, June 28th
- Ohio Discovery Dinner
- o Next one will be at Breitenbach Winery with an August 24 tentative date
- Hocking Hills wants to host a Discovery Dinner in the future- possibly fall

- Social Media
- o Since January our Facebook numbers are over 200,000 people reached
- Will be trying Reels (Like Tik-Tok for Facebook/Instagram) in the coming weeks
- Valley Vineyards is up and running again after taking the business back
- Recycled glass note of interest: After the collapse of the Philadelphia Bridge, they announced that they will be using crushed glass as a base for the reconstruction

New Business

- Vintage Ohio Update
- o The Vintage Ohio Festival needs to be reviewed and reinvented
 - To do at the Fall Retreat
- Currently there are 13 (possibly 14) wineries attending VO
- It was proposed to think about reducing VO to one day in August
- ODNR is hosting a legislative event on Middle Bass on August 19th, 2023
- \$75 per person and expecting 200 people
- Joe Glista and Joe Juniper will be supplying wine (1 ½ cases from each winery)
- o Brad Indoe expressed interest in supplying wine glasses
- OWPA wants to make a donation of \$1,000 to the project
 - A motion was made to approve the \$1,000 donation [Zdobinski/Cotton; unanimous]
- Lodge car show is set for Saturday, October 14th
- They are asking for wineries that are not from the area to participate
 - Hocking Hills
 - Vermillion Valley Vineyards
 - Maybe Gideon Owens Wine Co.
- Chrissy is working on V.I.N.O Wine Festival in Bowling Green on October 21st
 - Is set to take place during Bowling Green State University's Parents Weekend
 - The festival will be a part of the Parent's Weekend official program
- A Riedel Dinner was proposed to take place this fall at Spire Institute in Geneva, Ohio
- Karen Thorton at TTB reported that the Conneaut AVA and is very close to being finished
 - Lake Erie Islands AVA is in the discussion stages
 - Imed Dami and Robin Coolidge are taking the lead to get an AVA in Central Ohio
- Winter Wine Affair has been moved to Boardman from Stambaugh and is in a more upscale building
- An offer for the Association to purchase Wine Buzz Magazine
 - The attending board members agreed that we should set up a meeting to talk terms
 - A committee was formed to take this on
 - The members include Anita Davis, Joe Juniper, and Eric Cotton
- Wine America
- The main points talked about an Acreage Survey, Agricultural Appropriation Bill, Ingredient Labeling, and how wine is being considered a class 1 carcinogen
- o Fall meeting in Traverse City on November 13th and 14th
 - Donnie will not be attending
 - Joe Juniper, Anita Davis, and Eric Cotton are planning on attending
- o Roger Brooks came up to the area for a week to give some insight into regional marketing
 - His classes were to help implement a good marketing plan and maintain it
